



Unique People Services **Terms of Use**

Welcome to Uniquepeopleservices.org, the website and online service of Unique People Services (“Unique People Services,” “we,” or “us”). This page explains the terms by which you may use our online and/or mobile services, web site, and software provided on or in connection with the service (collectively the “Site”). By accessing or using the Site, you signify that you have read, understood, and agree to be bound by this Terms of Use Agreement (“Agreement”) and to the collection and use of your information as set forth in Unique People Services Privacy Policy, whether or not you are a registered user of our Site. This Agreement applies to all visitors, users, and others who access the Site (“Visitors”).

PLEASE READ THIS AGREEMENT CAREFULLY TO ENSURE THAT YOU UNDERSTAND EACH PROVISION. THIS AGREEMENT CONTAINS A MANDATORY ARBITRATION OF DISPUTES PROVISION THAT REQUIRES THE USE OF ARBITRATION ON AN INDIVIDUAL BASIS TO RESOLVE DISPUTES, RATHER THAN JURY TRIALS OR CLASS ACTIONS.

1. Use of Our Site

Unique People Services is Bronx Based organization that provides housing for individuals and families with special needs, specifically people living with HIV/AIDS, mental illness and developmental disabilities.

A. Eligibility

You may use the Site only if you can form a binding contract with Unique People Services, and only in compliance with this Agreement and all applicable local, state, national, and international laws, rules and regulations. Any use or access to the Site by anyone under 13 is strictly prohibited and in violation of this Agreement. The Site is not available to any Visitors previously removed from the Site by Unique People Services.

B. Unique People Services Site.

Subject to the terms and conditions of this Agreement, you are hereby granted a non-exclusive, limited, non-transferable, freely revocable license to use the Site for your personal, noncommercial use only and as permitted by the features of the Site. Unique People Services reserves all rights not expressly granted herein in the Site and Unique People Services Content (as defined below). Unique People Services may terminate this license at any time for any reason or no reason.

C. Site Rules

You agree not to engage in any of the following prohibited activities: (i) copying, distributing, or disclosing any part of the Site in any medium, including without limitation by any automated or

Accessing the audiovisual content available on the Site for any purpose or in any manner other than Streaming (as defined below) is expressly prohibited. “Streaming” means a contemporaneous digital transmission of an audiovisual work via the Internet from Unique People Services Site to a Visitor’s device in such a manner that the data is intended for real-time viewing and not intended to be copied, stored, permanently downloaded, or redistributed by the Visitor.

We may, without prior notice, change the Site; stop providing the Site or features of the Site, to you or to users generally; or create usage limits for the Site. We may permanently or temporarily terminate or suspend your access to the Site without notice and liability for any reason, including if in our sole determination you violate any provision of this Agreement, or for no reason. Upon termination for any reason or no reason, you continue to be bound by this Agreement. You are solely responsible for your use of Unique People Services Site. We reserve the right, but have no obligation, to monitor disputes between you and other visitors to the Site. Unique People Services shall have no liability for your use of the Site.

2. Our Proprietary Rights

A. Collection of Online Donations.

Unique People Services accepts donations through this website. All donations made via the Site are handled by a third-party independent payment processor not affiliated with, or controlled by, Unique People Services. Once you elect to make a donation through this Site, you will be directed to a third-party website to process your donation. The third-party payment processor may collect information from you, which may include your name, address, telephone number, email address, and credit card number. Upon receipt of your donation through this third-party payment processor, The Children’s Storefront may receive your contact information to provide you with a tax receipt for your donation and an acknowledgement letter. The Children’s Storefront does not collect, nor receive your credit card information.

B. Taxes. All information that you provide in connection with a donation through the Site must be accurate, complete, and current. You agree to be solely responsible for all tax consequences, if any, relating to any such donations.

4. No Professional Advice

If the Site provides professional information (for example, educational, legal or financial information), such information is for informational purposes only and should not be construed as professional advice. No action should be taken based upon any information contained in the Site. You should seek independent professional advice from a person who is licensed and/or qualified in the applicable area.

5. Privacy

We care about the privacy of our Visitors. You understand that by using the Sites you consent to the collection, use and disclosure of your personally identifiable information and aggregate data



as set forth in our [Privacy Policy](#), and to have your personally identifiable information collected, used, transferred to and processed in the United States.

6. Security

Unique People Services cares about the integrity and security of your personal information. You acknowledge that you provide your personal information at your own risk.

11. Governing Law and Arbitration

A. Governing Law. You agree that: (i) the Site shall be deemed solely based in California; and (ii) the Site shall be deemed a passive one that does not give rise to personal jurisdiction over Unique People Services, either specific or general, in jurisdictions other than California. This Agreement shall be governed by the internal substantive laws of the State of California, without respect to its conflict of laws principles. The application of the United Nations Convention on Contracts for the International Sale of Goods is expressly excluded. You agree to submit to the personal jurisdiction of the federal and state courts located in New York County, New York for any actions for which we retain the right to seek injunctive or other equitable relief in a court of



competent jurisdiction to prevent the actual or threatened infringement, misappropriation or violation of a our copyrights, trademarks, trade secrets, patents, or other intellectual property or proprietary rights, as set forth in the Arbitration provision below.

B. Arbitration. For any dispute with Unique People Services, you agree to first contact us at info@Uniquepeopleservices.org and attempt to resolve the dispute with us informally. In the unlikely event that Unique People Services has not been able to resolve a dispute it has with you after attempting to do so informally, we each agree to resolve any claim, dispute, or controversy (excluding any Unique People Services claims for injunctive or other equitable relief) arising out of or in connection with or relating to this Agreement, or the breach or alleged breach thereof (collectively, “Claims”), by binding arbitration by the American Arbitration Association (“AAA”) under the Commercial Arbitration Rules and Supplementary Procedures for Consumer Related Disputes then in effect for the AAA, except as provided herein. The arbitration will be conducted in New York County, New York, unless you and Unique People Services agree otherwise. Each party will be responsible for paying any AAA filing, administrative and arbitrator fees in accordance with AAA rules. The award rendered by the arbitrator shall include costs of arbitration, reasonable attorneys’ fees and reasonable costs for expert and other witnesses, and any judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction. Nothing in this Section shall prevent either party from seeking injunctive or other equitable relief from the courts as necessary to prevent the actual or threatened infringement, misappropriation, or violation of that party’s data security, Intellectual Property Rights, or other proprietary rights. ALL CLAIMS MUST BE BROUGHT IN THE PARTIES’ INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING, AND, UNLESS WE AGREE OTHERWISE, THE ARBITRATOR MAY NOT CONSOLIDATE MORE THAN ONE PERSON’S CLAIMS. YOU AGREE THAT, BY ENTERING INTO THIS AGREEMENT, YOU AND UNIQUE PEOPLE SERVICES ARE EACH WAIVING THE RIGHT TO A TRIAL BY JURY OR TO PARTICIPATE IN A CLASS ACTION.

12. General

A. Assignment. This Agreement, and any rights and licenses granted hereunder, may not be transferred or assigned by you, but may be assigned by Unique People Services without restriction. Any attempted transfer or assignment in violation hereof shall be null and void.

B. Notification Procedures and Changes to the Agreement. Unique People Services may provide notifications, whether such notifications are required by law or are for marketing or other business related purposes, to you via email notice, written or hard copy notice, or through posting of such notice on our website, as determined by Unique People Services in our sole discretion. Unique People Services reserves the right to determine the form and means of providing notifications to our Visitors, provided that you may opt out of certain means of notification as described in this Agreement. Unique People Services is not responsible for any automatic filtering you or your network provider may apply to email notifications we send to the email address you provide us. Unique People Services may, in its sole discretion, modify or update this Agreement from time to time, and so you should review this page periodically. When we change the Agreement in a material manner, we will update the ‘last modified’ date at the



bottom of this page. Your continued use of the Site after any such change constitutes your acceptance of the new Terms of Use. If you do not agree to any of these terms or any future Terms of Use, do not use or access (or continue to access) the Site.

C. Entire Agreement/Severability. This Agreement, together with any amendments and any additional agreements you may enter into with Unique People Services in connection with the Site, shall constitute the entire agreement between you and Unique People Services concerning the Site. If any provision of this Agreement is deemed invalid by a court of competent jurisdiction, the invalidity of such provision shall not affect the validity of the remaining provisions of this Agreement, which shall remain in full force and effect.

D. No Waiver. No waiver of any term of this Agreement shall be deemed a further or continuing waiver of such term or any other term, and Unique People Services' failure to assert any right or provision under this Agreement shall not constitute a waiver of such right or provision.
